Jeff Murski--Congressional Staffer and Texas A&M Class of '95---Officially Files for Brazos County Commissioner, Precinct 2

BRAZOS COUNTY, TX - Yesterday, I formally filed for Brazos County Commissioner Precinct 2. I announced my intent to run on July 7th and shortly after the incumbent announced he was not seeking re-election. Now, five months later, I am even more determined to earn the vote of Precinct 2 by sharing the vision and platform issues that have not changed since I first announced. As I stated then, I, along with many others, have witnessed questionable decisions made by our county government and a growing perception that it lacks transparency in the decision-making process. Even though some progress has been made to address existing issues, the trust between the voters and the elected officials remains low and improvement is required to move Brazos County forward to better days.

As a Congressional Staffer, I have developed and enjoy meaningful relationships with many County Judges, Commissioners, and Sheriffs throughout TX-17 after learning about their communities' needs and helping them. I am confident that I am uniquely equipped and best qualified to represent the citizens of Precinct 2; to service their needs and advocate for them. I will focus on these areas;

1. **Taxes:** The County continues to over collect tax revenue which has helped to grow the size and fed the appetite of County government. It has been demonstrated that growth can sustain our immediate and near future needs without raising taxes. In the recent past a '**No New Tax Revenue Rate**' was adopted by the Court. The County still ended up with a significant surplus of over \$21M. I will work hard to show the Court that we can achieve our financial goals while keeping our tax rate as low as possible. The taxpayer expects this, and I will work hard to deliver.
2. **Advocacy & Outreach:** I will treat this position as my full-time job for which the County compensates each Commissioner. Servicing your needs is important to me. I will make myself available to you with an open-door policy and return phone calls promptly. I will also work with the Court and Staff to see thru the decisions that increase our communication and outreach efforts via updated technology.
3. **Operational efficiencies:** It is easy to go after taxes; it is hard to go after efficiencies. I will do my very best to help the Court and Staff discover untapped efficiencies to save your money and incentivize County employees to foster a positive and productive work environment.
4. **Transparency and Priorities:** Based on continuing feedback from Precinct 2 constituents, our elected officials have many times chosen to focus on **their** wants and not on the needs of the taxpayer. I will defend the needs of the voter and advocate for more accountability when the wants of leadership are proposed. I will also lobby for increased and improved communications between staff and the Court on new projects and policies in addition to

the review of existing policies in place. I remain opposed to how the ***Inner East Loop*** project was handled. The County must find a better way to do business.

I want to help make Brazos County better. I want to FIX, not FIGHT. I am determined to help our County Government function and govern better. This will prepare the County to unite both of the cities and Texas A&M to collaborate on new and more meaningful initiatives.

Today is the day that I formally re-commit and continue to share my values and ideas to make this county a better place to live and raise a family and/or run a business. It is our responsibility as citizens to elect someone who is determined to rectify the situation at hand. I stand ready to earn your vote and follow through with integrity, honesty, and with YOUR best interests at heart; not just for one family, faction or entity.
